Participation Liability Waiver for Self and Immediate Family Members

I hereby acknowledge and agree to the terms outlined in this liability waiver on behalf of myself and all immediate family members (including but not limited to children, spouse, and any other dependents) participating in activities Kockatu Kids Foundation, Inc. (hereinafter referred to as "BK's Wild World").

Assumption of Risk: I acknowledge that participating in activities at BK's Wild World may involve certain inherent risks, including but not limited to physical exertion, use of equipment and facilities, and the possibility of personal injury or property damage. I understand that these risks cannot be eliminated entirely, even with the utmost care and supervision. I voluntarily assume all risks associated with participation in activities at BK's Wild World for myself and all immediate family members.

Release and Indemnity: In consideration for being permitted to participate in activities at the Facility (Tuttle Circle T Ranch), I hereby release and discharge BK's Wild World, Tuttle Circle T Ranch, their owners, directors, officers, employees, agents, and affiliates (collectively referred to as "Released Parties") from any and all claims, liabilities, damages, actions, or causes of action, whether known or unknown, arising out of or in connection with participation in activities at the Facility by myself and all immediate family members. This release extends to all claims, including but not limited to personal injury, property damage, or loss.

Medical Authorization: I authorize the Released Parties to obtain medical treatment for myself and all immediate family members in the event of an injury or illness occurring during participation in activities at the Facility. I understand that the Released Parties will make reasonable efforts to contact me or the emergency contact listed below before obtaining medical treatment, but if they are unable to do so, I authorize them to seek medical treatment, including hospitalization or surgery, as deemed necessary by medical professionals.

Compliance with Rules and Instructions: I agree that myself and all immediate family members will comply with all rules, regulations, and instructions provided by BK's Wild World. I understand that failure to comply with these rules may result in the immediate termination of our participation in activities at BK's Wild World.

Governing Law and Severability: This liability waiver shall be governed by and construed in accordance with the laws of Texas. If any provision of this waiver is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Staff members of BK's Wild World may take pictures and videos during the event. I understand the Facility reserves the right to use these photographs and videos for promotional materials, which may or may not include print media, social media posts, website photo gallery, etc. No compensation is paid for use of these photos. If for any reason you prefer that we not use pictures or videos of you or your child, please let us know immediately. Photography or video for any other purpose outside of personal use is strictly prohibited.

I agree to assume any medical or related expenses that may arise due to an accident, illness, or other incapacity, regardless of whether I have authorized those expenses at the time.

As a condition of receiving transportation, I, on behalf of myself, my child, our heirs, executors, and assigns, hereby release and forever discharge Kockatu Kids Foundation, Inc., its Board, staff, agents, officers, employees, 3rd party service providers, and volunteers from any and all claims, liabilities, damages, or actions that may arise in any manner from this transportation activity.
